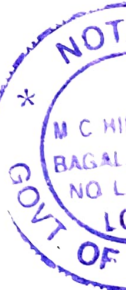

- 2) The Governing Council shall follow the conditions mentioned in Rule 4(4).
- 2) Subject to Providing facilities like School site, Area, Building, Lessons, sitting materials, financial ~~fixt~~ facilities to staff members etc.
- 4) The Trust at any Point of time shall not open Additional divisions without Prior permission of the Govt.
- 5) The Trust shall ~~not~~ change the Place or the Medium granted to it, for any reasons,
- 6) The Board Members to whom permission is granted to run the School in the particular place with title, shall run the School in the same place with same title.
- 7) The Board shall adopt all the Government orders passed in connection with the Education societies which are in force and shall also adopt the Government orders passed subsequently and also follow the acts and rules framed under Karnataka Education Bill 1983 (Karnataka Act No. 1:9 without fail.
- 8) This Primary School is registered as permanent un-aided School, as it is registered as per the circular No.ED-175-P-M-C-95- Dtd: 7-9-98 and 29-12-98.
- 9) The Board Members shall execute in affidavit on a stamp Paper worth Rs.20/- sworn before Notary undertaking that they would not for any kind of Grant from the Govt.

- 11) The Trust shall adopt Syllabus and examination procedure fixed by the Dept. & Govt. without fail.
- 12) Within the period of two months of the Opening of School, first recognition Proposal form shall be filed in the Office of Deputy Director.
- 13) As per Govt order No.ED-28 PGC 94 - Dtd: 29-4-94 from Ist Standard to 5th Standard shall be run in Kannada language or in the mother language of the Students and the Schools which are following the language rules may seek Permission for upgradation from 6th standard in Kannada Medium.
- 14) If it is noticed by the Govt/Dept/Kannada Development Authority that the Schools, which are registered under the language rules, are violating the language rules, the permission and registration granted to such schools shall be cancelled as per rules. If the documents filed along with the Registration proposal are found bogus or vague, in any circumstances, the registration proposal shall be cancelled at any time.

- 15) ~~The~~ In order to open the School, the Trust shall deposit Security deposit in the Joint A/c opened in the name of Dist. Deputy Director and the Secretary of Administrative Board.
  - 16) In each Permitted division, the ratio among the students and Teachers shall be in accordance with rules. 40 Students shall be present out of 50 students in each Division.
  - 17) The Trained and qualified Teachers whose educational qualification is as per the Department rules, can only be appointed as Teacher.
  - 18) All the Schools registered under Karnataka Education Bill Article 8 Sub Section 36-39 come under the Perview of Recognition and Provisional recognition.
  - 19) Medical Check up of the students be made every year, as per rules.
  - 20) As per the rules of Karnataka Education Bill, the required study materials, ~~furnitures~~<sup>W</sup> furnitures and library books, Play ground and School building should be provided within one year, otherwise the registration will be cancelled.
  - 21) School working hours and working days should be as per department rules.
